**Summer #82 is approaching!** And, of course, it wouldn't be complete without our "infamous" weekends for campers, non-campers, alumni-campers, shouldabeen-campers and gunnabe-campers -- for an exciting mini-camp experience. Folks still NEW to camping will get a firsthand try at camp activities, meet folks behind the scenes and get a feel for our approach to kids and camping. Experienced La Junta folks will get a chance to enjoy La Junta and the outdoors in a relaxed, family atmosphere.

**IT'S A "GUY THING:"** We'd like to keep things limited to our traditionally male population. However, we will not exclude any moms or sisters who want to "rough it" with the guys for a weekend. Ladies should remember our facilities will remain rustic and group oriented, but we'll do our best to make you feel "at home."

**Three Weekends: April 18/19, April 25/26 or May 2/3**

**PURPOSE:** For over 15 years we have watched campers and dads enjoying themselves at Father/Son weekend. While initially we thought it would simply be a great way for new campers to learn the lay of the land before their first Camp La Junta experience, we have become firm believers that it is also a great bonding experience. How often these days can a boy and his favorite Role Model spend an entire weekend just hanging out? From the drive out to camp to an afternoon paddling the peaceful Guadalupe, it's just a great time for strengthening relationships and for creating memories.

**PROGRAM:** Father/son weekends traditionally function with a resort style atmosphere. The only firmly scheduled events each day will be meals. Activities will include riflery, archery, canoeing, kayaking, swimming, tennis, athletics, hiking and horseback. No counselor supervision is provided for most activities (with the exception of riflery, archery and horseback) and families choose when they will try each activity. Your schedule is yours to create. The atmosphere is designed such that a father and son(s) spend the weekend together, creating their own entertainment while getting to know La Junta and it's personnel a little better. \* You will be given a schedule for riding (for boys only), riflery and archery when you arrive, so that everyone will have a turn at these La Junta Staff-supervised activities. Commemorative T-Shirts will be given to everyone!

**ARRIVE** anytime Friday after dinner or Saturday, but please let us know your arrival plans on the application form. Friday evenings do not include dinner, but will have some sort of event starting after dark.

**MEALS:** Five meals, starting with Saturday's hearty breakfast and finishing with a light Sunday, lunch will be served. Snacks and a campfire will be available on Friday evening for those who arrive before bedtime.

**LODGING:** We will assign you and at least 2 other families to a cabin, but will consider your special requests for cabinmates. Please indicate any preferences on your registration form.

**COST:** \$200.00 per pair of people plus \$25.00 for each additional boy in your group. In typical La Junta fashion, fees are all inclusive. Sorry, we can't make partial allowances or prorations.

**Please limit three boys per adult. Boys under 13 only, unless registered for camp.**

CAMPER AND PARENT desire to use and participate (“Participation”) in the activities, programs, recreation and facilities of CAMP's Father/Son Program (collectively “Activities”).

PARENT AND CAMPER acknowledge the activities may include swimming, canoeing, kayaking, ropes course, hiking, horseback riding, soccer, flag football, softball, crafts, tennis, riflery, archery, fishing, volleyball and other group games, sports and activities. PARENT AND CAMPER realize that some of these Activities may subject those involved to certain stresses and hazards, not all of which can be foreseen. PARENT AND CAMPER desire and consent to all such Activities. PARENT AND CAMPER assume all of the ordinary risks normally incident to the nature of the Activities to be conducted. PARENT AND CAMPER will stay together for the duration of their stay and choose their activities, therefore CAMPER is cleared for any activity PARENT chooses for him to participate.

PARENT has disclosed and provided all information regarding CAMPER for Participation. PARENT acknowledges and understands that no warranty, either express or implied is made by CAMP as to the CAMP premises nor the Activities, that dangerous conditions do exist and THAT THIS DOCUMENT IS SUFFICIENT WARNING that there are numerous dangerous conditions, risks and hazards involved in Participation and that the Participation will expose CAMPER to such numerous dangerous conditions, risks and hazards. PARENT further hereby states and confirms that PARENT INDIVIDUALLY AND ON BEHALF OF CAMPER EXPRESSLY ASSUMES ALL SUCH RISKS, HAZARDS AND DANGERS of the Participation with the understanding that CAMPER will be exposing both person and property to same. Under Texas law (Chapter 87, Civil Practice and Remedies Code), an equine professional is not liable for an injury to or the death of a Participant in equine activities resulting from the inherent risks of equine activities.

IN CONSIDERATION FOR THE RIGHT TO PARTICIPATE IN CAMP ACTIVITIES PARENT AND CAMPER DO HEREBY RELEASE CAMP AND AGREE TO PROTECT, INDEMNIFY AND HOLD HARMLESS CAMP FROM AND AGAINST ANY AND ALL DAMAGES, CLAIMS, DEMANDS, CAUSES OF ACTION OF ANY SORT, INCLUDING ATTORNEY’S FEES, RESULTING FROM ANY ACCIDENT, INCIDENT OR OCCURRENCE ARISING OUT OF, INCIDENTAL TO OR IN ANYWISE RESULTING FROM CAMPER’S PARTICIPATION REGARDLESS OF whether same may result from NEGLIGENCE OF CAMP. PARENT hereby further covenants and agrees for PARENT AND CAMPER that PARENT AND CAMPER WILL NOT MAKE ANY CLAIM NOR INSTITUTE ANY SUIT OR ACTION AT LAW OR IN EQUITY AGAINST CAMP arising out of or related to CAMPER’S Participation and/or the Activities.

PARENT AND CAMPER also understand that CAMP STRONGLY discourages bringing valuables such as radios, walkmans, CD or DVD players, CDs or DVDs, gameboys and expensive jewelry. If you choose to bring such items you understand that you do so solely at your own risk. CAMPER AND PARENT shall be liable for any damage to the property or facilities of CAMP or of the property or facilities of others resulting from acts of CAMPER AND/OR PARENT either solely or in concert with others which are not routine actions of the CAMP program, whether accidental, intentional or malicious.

PARENT AND CAMPER give permission and consent to the taking of photographs, video, and interviews and give permission and consent for any such photographs, videotapes, or interviews to be published and used for advertising, promotion, publicity, or recreational viewing in publications and internet web sites related to CAMP or CAMPMINDER and their respective camping activities. PARENT AND CAMPER waive all claims for any compensation for such use or for damages.

The mandatory venue – the place where any case or dispute must be brought – shall be exclusive to Kerr County, Texas, and any action, suits or claims regarding CAMP and/or arising from PARENT or CAMPER’S Participation shall be brought and maintained in Kerr County, Texas.
